

**A RESOLUTION**

**AMENDING AND CORRECTING RESOLUTION 2022-01, A RESOLUTION APPROVING PREMIUM PAY TO CERTAIN EMPLOYEES WITH AMERICAN RESCUE PLAN ACT FUNDS AND DECLARING THAT SUCH PAY IS A ONE-TIME, LUMP SUM PAYMENT AND NOT PART OF THE REGULAR SALARY BASE, TO CORRECTLY STATE THE AMOUNTS TO BE PAID TO A CERTAIN EMPLOYEE AS WELL AS THE TOTAL AMOUNT TO BE DISBURSED TO ALL EMPLOYEES**

**WHEREAS**, American Rescue Plan Act (ARPA) Local Fiscal Recovery Funds may be used to provide premium pay to eligible workers performing essential work during the COVID-19 public health emergency; and

**WHEREAS**, the City of Seneca (“the Municipality”) passed Resolution 2022-01 on January 11, 2022, approving premium pay to certain designated employees as reflected on Exhibit A attached thereto; and

**WHEREAS**, there were scrivener’s errors in Exhibit A to Resolution 2022-01 in which one employee’s hours were overstated and, similarly, the amount owed to said employee as well as the amount due to all employees in the aggregate were overstated; and


**WHEREAS**, the funds distributed to the employee were in the correct amount pursuant to their actual hours worked and not in the overstated amount; and

**WHEREAS**, the Municipality desires to amend Exhibit A to Resolution 2022-01 in order correct the scrivener’s errors contained therein.

**NOW, THEREFORE, BE IT RESOLVED** that the Council of the Municipality hereby approves the premium pay under ARPA to the employees shown in Amended Exhibit A attached hereto, repealing and replacing Exhibit A which was attached to Resolution 2022-01. All other intentions, declarations, authorizations, and provisions of Resolution 2022-01 shall remain in full force and effect as if fully set forth verbatim herein.


